Dear Ms. Worley:

We have been retained by the Centre for Addiction and Mental Health, Dr. Ray Blanchard and Dr. Ken Zucker as a result of a number of emails you have disseminated which erroneously and maliciously allege that all or some of my clients have been engaged in illegal, immoral or unethical activity. These defamatory allegations are totally unfounded and have the potential, if further disseminated, of continuing to do great harm to the professional and personal reputations of my clients.

The purpose of this letter is to put you on formal notice that my clients will not tolerate the dissemination of defamatory statements about them and to demand that you immediately cease all such activity and apologise.

In addition to your more generalized defamatory allegations, you have referred to certain of my clients as having "...created human atrocities", and state that "And he (sic) most horrific atrocities stem right here in Toronto", suggesting that my clients are irresponsible, immoral, unethical and engage in criminal behaviour.

In yet another part of your widely disseminated emails, you further damage the reputation of my clients by accusing them of participating in "criminal action and gross misconduct".

As you can no doubt appreciate the reputation of each of my clients is very important to them and your false and defamatory statements disseminated, as they are, to a wide audience is clearly calculated to harm their reputations and cause them damage personally and in their trade or profession. My clients reserve the right to bring this malicious conduct to the attention of the Court

if you continue to defame my clients, as evidence of malice in support of a claim for punitive and exemplarily damages.


In order to remedy the severe assault on my clients' reputations demand that you send an email to all recipients of your past emails in which you disparage my clients' reputations and apologise for having made false and defamatory remarks. We would be pleased to communicate with you about the wording of the email if that would be of assistance.

My clients are certainly willing to engage in reasonable discussion about matters that relate to their work in relation to the Gender Identity Clinic and do so regularly. However, your outrageous and offensive conduct has caused them to conclude that further communication with you would not be useful.

Accordingly, all future communications you wish to have with any of my clients should be through my office.

Please be advised that my clients reserve the right to refer to this letter and all of the emails in which you have disparaged my clients' reputations as evidence of your malice if you fail to immediately cease disseminating defamatory statements and if you fail to apologise within ten days of receipt of this letter.
